- ☼ Stabling for \$50/night. Day before schooling from 3 to 5 pm for \$20/horse. Contact Lynne (775) 722-4261.
- ☼ *Classes Warm Up A & B, #10, #25 and #26 are not SNHSA-sanctioned and year-end points will not accrue.
- ☼ Awards to 1st and ribbons through 5th. Prize money for Stake Classes awarded through 4th only if 5 or more entries:
1st 50%; 2nd 25%; 3rd 17%; 4th 8%.
- ☼ There is a \$5 per horse, non-refundable horse fee required by SNHSA.
- ☼ A \$20 SNHSA non-member fee is required for riders entering SNHSA-sanctioned classes.
- ☼ **SNHSA requires that dogs be on a leash at all sanctioned events.** Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors.
- ☼ **Horses/ponies may not enter and show in more than six (6) classes in a day.**
- ☼ All cross-entry rules apply for classes entered. Please refer to the Rule Book available online at www.SNHSA.org for a complete set of rules.
